2. WHAT IS THE TOTAL UNDERSPEND FOR THE ALLIANCE WITH WARWICKSHIRE POLICE FOR POLICE OFFICER WAGES FOR THIS FINANCIAL YEAR TO DATE? **£7.7 million**

3. HOW MUCH MONEY/INVESTMENTS DOES WEST MERCIA POLICE HAVE IN RESERVES AT THIS TIME? **£53.1 million**

4. HOW MUCH MONEY/INVESTMENTS DOES THE ALLIANCE WITH WARWICKSHIRE HAVE IN RESERVES AT THIS TIME? **£86.3 million**
