
Ave no. of days to finalise allegations by local investigation


Ave no. of days to finalise allegations by local investigation



IPCC investigation appeals 01 April 2014 to 31 December 2014




IPCC non recording appeals 01 April 2014 to 31 December 2014





IPCC investigation appeals 01 April 2014 to 31 December 2014




IPCC non recording appeals 01 April 2014 to 31 December 2014




Force investigation appeals 01 April 2014 to 31 December 2014



Force local resolution appeals 01 April 2014 to 31 December 2014




