A complaint was initiated in 1/13 by detainee's solicitor on the grounds that Superintendent had excluded the solicitor from interviews with detainee. The complaint became complicated by the fact that the Superintendent retired before he had answered all the questions put by the team investigating the complaint. The criminal investigation too was delayed by the Superintendent's retirement. Reasonable time scale.

CO/00762/13	M & J	Complainant made an accusation of 'serious corruption' against an Officer which almost led to an innocent man being accused of child abuse. The child involved was the daughter of the complainant, the niece of the PC. The complaint investigation was ultimately discontinued because of the lack of cooperation of the complainant. Case well investigated and time scale was as short as could reasonably be.		
CO/00712/13	M	Complaint raised 19.05.13. Resolved 5 Dec 14. Initial complaint was disagreement between neighbours and police officer who lived next door accusing the officers of a number of incidents, including noise, dog trespass, etc. All investigated and found no case t answer after appeal. No appeal to IPCC as it went to the Appeals Panel.		
CO/00397/13	В	Complaint raised 8 Jul 13 finalised 02 Dec 14. Complainant stopped for not wearing seat belt, officer smelt cannabis and searched car. Complainant alleges in the search his genitals were touched by the officer. A small amount of cannabis was found in the car. The complainant believes he should not have been searched
