# POLICE & CRIME PLAN ACTIVITY AND PERFORMANCE MONITORING REPORT

### 1. Purpose

The purpose of this report is to provide members of the panel with an update on progress in delivering the Police and Crime Plan for West Mercia 1 April 2013 – 31 March 2017 including a performance report in relation to the success measures contained within the plan and a brief outline of other key commissioner activity.

This report covers the time period 1 June 2013 – 30 September 2013.

### 2. Background

The Police and Crime Plan for West Mercia came into effect on the 1 April 2013 and sets out the aim and objectives of the Police and Crime Commissioner (PCC) for policing and community safety across West Mercia. The plan contains four strategic aims, underpinned by eleven objectives and a range of performance measures. The plan also sets out governance and accountability arrangements.

### 3. Format of the Report

This report is presented in three sections as follows:

**Part 1** - an update on progress for each of the objectives listed in the plan.

**Part 2** – a quarter 2 performance monitoring report for the performance measures set out in the plan.

**Part 3** – a brief outline of the PCC's key activity in relation to role and function not captured in parts 1 or 2 of this report.

### 4. Part 1 – Update on Police and Crime Plan Objectives

The police and crime plan came into effect on 1 April 2013 and the activity reported here covers the period 1 June to date. For each objective a short narrative on activity is provided. Details of associated performance measures/outcomes are contained within part 2 of this report.

# Objective 1 – To provide an effective neighbourhood policing model, with a focus on areas of greatest need

The new alliance policing model came into effect on the 30<sup>th</sup> September 2013 across the whole of West Mercia and Warwickshire. In West Mercia, 82 Safer Neighbourhood Teams have replaced the local policing teams, each SNT is managed by a police sergeant, one police constable and two Police Community Support Officers (PCSOs). Twenty of the SNTs have been identified as higher demand areas and have two police constables and four PCSOs allocated to them.

In these area one of these PCSOs will be based at a local school as part of the forces' Safer Schools Programme. Eleven patrol bases have also been established in West Mercia to support the safer neighbourhood teams.

To enhance the new policing arrangements Police Community Support Officers (PCSOs) have been granted a wider range of powers than they previously had. The new powers relate to young people, issues involving the unlawful possession of alcohol and drugs and traffic obstruction. In addition, an investment in mobile technology means that officers are able to access information and complete paperwork on the go rather than returning to base.

The town and parish council survey has been completed and the results are currently being analysed. It is anticipated that the results will be available by the end of October 2013

# Objective 2 – To reduce the volume of violent crime with an emphasis on addressing the harm caused by alcohol through partnership working

Work to develop a joint strategy with partners to reduce violent crime linked to the misuse of alcohol is progressing and West Mercia's Community Safety Partnerships have all provided details of relevant strategies and plans to assist in this process.

# Objective 3 – To reduce the harm caused by drugs with a focus on treatment, and targeting those that cause the most harm

A West Mercia and Warwickshire drugs strategy was launched at the end of July 2013. The strategy forms a separate agenda item to this Police and Crime Panel meeting.

The PCC and his office are engaged with local commissioners and service providers. Grants totalling £333,460 have been awarded to practitioners to deliver drug intervention programmes, education and prevention sessions, diversionary work and care programmes.

#### Objective 4 – To reduce the volume of anti-social behaviour incidents

Work to develop a joint strategy with partners to reduce ASB is progressing as the volume of anti social behaviour incidents reported to the police has continued to fall. The volume of incidents reported to September 2013 is 8.9% lower than as at September 2012.

#### **Objective 5 – To bring offenders to account and reduce re-offending**

Integrated Offender Managers (IOM) teams are working with local commissioners and service providers to ensure the needs of IOM nominals are being met. Grants have been awarded to drug intervention and testing programmes which support reducing reoffending. Grants have also been issued to support IOM teams and crime prevention programmes linked to reducing reoffending. The PCC / DPCC and his office are also working closely with service providers and partners to build sustainable funding streams through the development, or enhancement of social enterprise models.

The PCC and West Mercia Criminal Justice Board are working with CJS partners, 3rd sector and stakeholders to improve the use of Restorative Justice programmes, diversion projects, treatment services and crime reduction initiatives. This includes working with Willowdene, ASHA, Stoke Heath and HMP Hewell to improve programmes and projects linked to reducing reoffending. In addition work is ongoing with YSS to improve commercial viability of certain social enterprise models in operation across West Mercia.

### **Objective 6 – To develop and implement a business crime strategy**

Two workshops were held in September, one to bring together a range of business representatives and other interested parties to identify the key business crime issues across West Mercia and Warwickshire, and one to bring together organisations and individuals to identify key rural crime issues. The feedback from these meetings and will be used to assist in the development of both a business crime strategy and a rural crime strategy.

# Objective 7 – To work in partnership to protect the most vulnerable people in our society

A multi agency safeguarding hub has been established in Herefordshire and the PCC is seeking to support the force team set up to ensure a roll out of the hubs in Worcestershire, Shropshire and Telford & Wrekin.

Separate draft strategies have been prepared for domestic violence and sexual violence. These are currently out to consultation with partners.

# Objective 8 – To deliver a supportive and effective response to victims and witnesses

A West Mercia Criminal Justice Board restorative justice strategy has been put in place and out of court disposal guidance has been issued. It is anticipated that an alliance wide out of court disposal strategy will be in place by April 2014.

# Objective 9 – To work with the Safer Roads Partnership to reduce the number of casualties on our roads

A draft Casualty Reduction Strategy, including speed reduction initiatives, has been prepared and is under review by the Force. In conjunction with the PCC and Chief Constable, a Community Speedwatch Programme is being developed for consideration and is due by the end of October 2013

#### **Objective 10 – To meet the requirements of the Strategic Policing Requirement**

Strategic Policing must be provided at a standard to satisfy the Home Office Strategic Policing Requirement. The Police and Crime Commissioner has made a significant allocation of the Police Fund for this purpose and is able to monitor levels of provision in liaison with the responsible Assistant Chief Constable.

Strategic Policing increasingly involves engagement at a Regional level and t he Police and Crime Commissioner has attended regional meetings as part of the development of Police and Crime Commissioner oversight of the Regional Organised Crime Unit.

The Police and Crime Commissioner continues to support the Central Motorway Patrol Group.

### **Objective 11 – To develop and implement a public engagement strategy**

In September a recruitment drive began to find five Community Ambassadors, as part of the Police and Crime Commissioners Community Ambassador Scheme.

The draft Community Engagement Strategy went out to consultation in September / October. The final version of the strategy will be issued by the end of October 2013.

Since the 1 June, the PCC and his Deputy have continued to meet with a range of organisations and community groups to open discussions and engage with local people on local issues.

#### Grants

 The West Mercia Commissioner's grant scheme was launched in April to provide financial support to initiatives that contribute to reducing crime and disorder or delivery of the West Mercia Police and Crime Plan.

The scheme established procedures to access a total fund of £2m. Of this figure £990,000 may be recovered from central funds for Community Safety provision. (These were the funds formerly allocated to Community Safety Partnerships and to the Youth Offending Service.)

It is understood that after 1 April 2014 these funds will no longer be recoverable from central government but will be a drain on the Police Fund. The Commissioner has expressed an intention to maintain the scheme fund at £2m throughout his period of office (subject to changes in the overall financial position.)

To the end of September 2013 74 grants have been awarded totalling  $\pounds$ 1,597,840.

 The Commissioner has also established a small private fund of £20,000 to support organisations that help fight crime and support victims of crime. From April to December 2013 a maximum of £500 will be paid to successful applicants.

#### 5. Part 2 – Performance monitoring report

The Police and Crime Plan contains a range of performance measures developed in conjunction with the Chief Constable that enable the PCC to monitor both the performance of West Mercia Police and the implementation of the objectives set out in the plan.

Each measure contained within the plan has an agreed target or outcome. In addition, a number of measures were identified in the plan as being 'headline measures'. These are the key measures by which the Chief Constable holds the force to account and are reviewed at every Force Performance Group, which is attended by the PCC and/or his deputy and officers for the Office of the PCC.

The measures are shown in full in **Appendix A**, with the latest performance data shown where appropriate or a short comment for measures with an outcome focus. A 'RAG' rating has also been applied to each measure as follows:

**Green** – this indicates the target / outcome is at or above the expected position. **Amber** – this indicates that the target / outcome is marginally below the expected position

Red – this indicates the target /outcome is below the expected position

The data for a small number of measures is not available for this report, it will be provided to the panel when available and published on the OPCC website.

**Headline Measures** – To the end of September the measures in the plan which have been defined as headline measures are all on target, except for road traffic collisions and the detection rate for serious sexual offences. The PCC will continue to scrutinise the forces performance in these areas.

**Other measures** – To date, progress against the measures shown is acceptable and the PCC does not have any immediate concerns at this time.

### 6. Part 3 – PCC Activity

The following provides a brief outline of key PCC activity not captured in parts 1 or 2 of this report, but which will be of interest to the panel. This update relates to the period 1 June to date.

**Independent Joint Audit Committee** – the committee met in September and received updates as to the work and findings of both external audit (Grant Thornton) and internal audit teams. No areas of concern were highlighted. The Committee also considered the risk registers of both OPCC offices and a joint Strategic risk register for Warwickshire and West Mercia Police.



The Shropshire and Telford and Wrekin Safe Places initiative was launched. This initiative provides a network of 'havens' for people who may require additional support and assistance when they are out and about in the community.

### August

The first of a small fleet of mobile police stations, which are currently being introduced across the West Mercia area, was launched in Shrewsbury.

A protocol was adopted to work collaboratively with Energize, a county sports partnership covering Shropshire, Herefordshire and Worcestershire, on grants to support community sport.

### September

The PCC joined many others to wave farewell to 14 senior cadets from the Telford Volunteer Cadets. Due to the scheme's success, the day also saw the launch of five new detachments of West Mercia Police Cadets covering the whole of the West Mercia area.

The PCC has attended the Annual Regional Conference of the Independent Custody Visiting Association (ICVA). Their role is extremely valuable in providing transparency in how West Mercia Police treat their detainees in custody.

Following a successful initial meeting instigated by the PCC and Deputy, Walford College and HM Stoke Heath Prison have started working together to find more rehabilitation opportunities for prisoners.

The PCC visited the Shrewsbury Auction Centre to talk to farmers about rural crime. The visit proved very worthwhile and a number of them gave their views on the issues that affect them living and working in the countryside.

### 7. Recommendations
