FOI Query.

Dear FOI Officer,

I am writing to request information under the Freedom of Information Act 2000. In order to assist you with this request, I am outlining my query as specifically as possible.

For each financial year 2009/10, 2010/11, 2011/12, 2012/13, 2013/14, 2014/15, 2015/16, 2016/17 (if possible. If not then please provide for calendar year):

- 1. How much was spent by the PPC on services for:
 - a. Victim's services
 - b. Sexual Violence/domestic violence
- 2. Broken down by year, please provide details of the types of sexual violence/domestic violence programmes that were funded e.g. refuge shelters, counselling, work with male perpetrators.

If my request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions of the Act. I will also expect you to release all non-exempt material. I reserve the right to appeal your decision to withhold any information or to charge excessive fees.

I would be grateful if you could confirm in writing that you have received this request. I look forward to your response within 20 working days, as outlined by the statute.
