Enabling Works for Combined Projects

EXECUTIVE SUMMARY

Enabling works are required as the next stage of the West Mercia Combined Works Project. These can be progressed using an Enabling Works Delivery Agreement in the form of a commonly used NEC Short Form Contract.

The enabling works include site set up, soft strip, asbestos removal and other preparatory items. This is in advance of the main Delivery Agreement (NEC Option A Contract) being prepared to be considered for approval due course. This approach will shorten the overall project period and substantially reduce associated costs.

PROPOSAL

This proposal is to undertake enabling works in advance of major works to the Hindlip and Telford complexes. Completion of the Enabling Works Delivery Agreement will allow contractors to proceed with the necessary works immediately.

A number of contractors have provided costs within each discipline to obtain competitive costs and these costs have been interrogated and verified as acceptable by cost consultants and Place Partnership Limited.

The West Mercia Combined Works Project relates to a number of properties and takes advantage of the nationally recognised SCAPE Framework procurement route. The benefits are wide ranging and include:-
