The West Mercia PCC has participated in the White Ribbon campaign in each of the last three years. Participation has not incurred any costs form a communications or engagement perspective for the PCC.

As White Ribbon is a national campaign it is impossible to list all contributors and partner agencies. Typically at a local level though these have included West Mercia Police, local councils, charities, Community Safety Partnerships and support services for victims of crime.

In the timeframe stipulated the Commissioner's office has also supported a number of grant applications, either directly or indirectly via Community Safety Partnerships, which have enabled or facilitated campaigns to raise awareness of domestic violence.
