## TITLE

HWFRS Co-location at Hindlip HQ - New Lease

Ref: PCC/D/2018/18

### **EXECUTIVE SUMMARY**

Hereford and Worcester Fire Authority wish to co-locate the HQ of Hereford & Worcester Fire and Rescue Service (HWFRS) at West Mercia Police HQ, Hindlip. This will improve inter-agency working, effectiveness and efficiency.

Refurbishment and works to some floors are required to create the additional capacity and a modern working environment.

Hereford and Worcester Fire Authority will take a lease of the required areas of Hindlip HQ to facilitate this co-location opportunity.

## **PROPOSAL**

To grant a 125 year lease to Hereford and Worcester Fire Authority and undertake a scheme of works to facilitate more efficient use of the available space at Hindlip HQ. Relocation to Hindlip will allow HWFRS to vacate their existing building at Kings Court and reduce their overall accommodation costs.
