EXECUTIVE SUMMARY

Following a review of facilities in Worcester Police station, it has become apparent that refurbishment works are needed.

The purpose of the refurbishment is to ensure that the report writing report, the SNT offices, the CID offices and the corridor/kitchenette provide a suitable working environment and enhance operational effectiveness.

PROPOSAL

This proposal is to approve the refurbishment of Worcester Police Station at an estimated cost of £135,400 and agree that this be funded from the provision for the Investment in Estates Infrastructure Project set aside in the 2019/20 Capital Programme .

SUPPORTING REPORT

The report writing room, the SNT offices, the corridor/kitchenette and the CID offices require refurbishment. The works will include

- · Decant of existing offices and staff
- Redecoration
- Provision of new carpets and furniture
- Installation of new power and data
- Provision of new installed storage (and move of existing stored resources)
- Inspection and replacement of ceiling tiles (if required)
- IT/Wall Signage
- · Asbestos Survey and any associated works

FINANCIAL COMMENTS

The estimated total refurbishment costs are £135,400, which include Project Management, Consultant and Building Regulation fees. These costs can be funded from the provision for the Investment in Estates Infrastructure Project set aside in the 2019/20 Capital Programme.

A number of contractors have provided costs within each discipline to obtain competitive costs and these costs have been interrogated and verified as acceptable by cost consultants and Place Partnership Limited.
