West Mercia Police and Crime Commissioner

At a meeting 05/09/2019 in Market Drayton the PCC remarked on a CCTV Fund of £1.25m.

I wonder if you can release a list of recipients of that Fund. Who got what and why and an indication of what (if anything) is left of the Fund.

I know that Market Drayton applied via Shropshire Council in early 2017 but it seems nothing was ever heard in response.

Hope you can help

Response.

- Q1. The PCC can confirm that there is CCTV Fund of £1.25m which is due to run over a 3 year period (2017-2018, 2018-2019 and 2019-2020) across the West Mercia Police area.
- Q2. The link below to the PCCs Website provides a list of the recipients of the Commissioners Grant Scheme (CGS) including details of who has received funding for CCTV.

The table below shows the total fund allocated for CCTV in Shropshire across the three years. The following areas were also successful in grant applications because they satisfied the appropriate criteria to qualify in line with standard PCC policy.

The total grant allocated was £245,000 and the remainder available is £172,271 and the Grant Applications received over the three years are:

Complaints
