#### **EXECUTIVE SUMMARY**

Operation Lincoln is the investigation into Maternity Services at Shrewsbury & Telford Hospital Trust. This is going to be a long running, large scale major investigation. Due to the scale of the investigation the number of officers and staff involved is expected to increase as key lines of enquiry are developed.

In order to faciliate the deployment of such a significant number of staff, suitable accomodation is required. It is essential that a main site (incident room) is identified with good transport links to allow both staff to be attracted to the location, but just as importantly to ensure travelling time for the purpose of enquiries is manageable. The central team are currently temporarily housed in a classroom at Hindlip which does not meet the needs of the Operation and will impede on training arrangements in the longer term.

Enquiries to date have failed to identify a suitable location within the police estate. Suitable accommodation outside the police estate has been identified.

The proposal is aligned to and should be read in conjunction with a bid for a Special Grant to fund the investigation.

#### **PROPOSAL**

To lease the accommodation identified to provide suitable accommodation for Operation Lincoln.
