EXECUTIVE SUMMARY

In February 2021, the Home Office published new Police Pension Forfeiture Guidance. Following publication of the new Home Office guidance, the Police Officer Pension Forfeiture Policy has been reviewed and amended to ensure it remains compliant with the latest national guidance.

That the Police and Crime Commissioner and Chief Constable approve the revisions to the Police Officer Pension Forfeiture Policy and that the policy is implemented and published on the PCC's website.

PART 1 - NON-CONFIDENTIAL/EXEMPT FACTS AND FIGURES

SUPPORTING REPORT

The Police Officer Pension Forfeiture Policy was originally developed, agreed and published in December 2018 The policy was based on guidance set out within the Home Office Circular 018/2009 Forfeiture of Police Pensions

On 11/02/2021, the Home Office published new Police Pension Forfeiture Guidance and two process maps (one for officers, and one for police staff), which replaced the previous Home Officer Circular 018/2009. Following publication of the new Home Office guidance, the policy has been reviewed to ensure it remains compliant with the latest national guidance

Although there are no substantive changes to the procedures set out by the Home Office, the new guidance provides further clarity on process, particularly in relation to submitting an application to the Home Secretary, and the right of appeal

Key changes are summarised below:

- The new Home Office guidance focuses primarily on the application to the Secretary of State and the decision making process at that stage. There is no guidance on the Chief Constable's provision of information to the PCC to enable such an application, or the PCC's decision making process in respect of forfeiture As such, these sections (Section 4, 7 & 8) remain relatively unchanged, and are based on a national PCC template
- However, a number of additional paragraphs have been included in Sections 4, 5 & 6 to ensure the PCC and Home Secretary are provided with all relevant information on which to make reasonable and rational decisions, and to enhance transparency of the process for all parties.
- More comprehensive information provided in respect of the appeals process as set out at Section 10.

The final draft policy can be found as an appendix to this decision notice. The policy has been reviewed by the PCC's Chief Executive, the Deputy Chief Constable, the Head of Commercial Services, the Head of the Professional Standards Department and Legal Services.

FINANCIAL COMMENTS

There are no immediate financial considerations. However, should the policy be invoked, West Mercia Police's pay and pension administrators must be notified of the potential forfeiture.

By virtue of schedule 11, paragraph 14 of the Police Reform and Social Responsibility Act 2011 the Police and Crime Commissioner may do anything which is calculated to facilitate, or is conducive or incidental to, the exercise of the functions of commissioner. That includes: entering into contracts and other agreements (whether legally binding or not) and acquiring and disposing of property (including land)

PCCs have responsibilities for dealing with Police Pension forfeiture as set out in Police Regulations and the HO Guidance
