An OOCD can only be used in limited circumstances – for specified crimes within the remit. Out of court disposals include NFA, community resolution, youth caution supported with intervention, youth caution, youth conditional caution, referral back for consideration to charge. A driving principle for OOCDs is to reduce re-offending by enabling restorative and reparative justice. The PCC provides an annual grant for extra staff/capacity (equivalent to 2.5 FTE workers) contributing to the reducing youth re-offending outcomes across West Mercia.
