TITLE: APPOINTMENT OF CHIEF CONSTABLE

EXECUTIVE SUMMARY

Section 38 of the Police Reform and Social Responsibility Act 2011 (the Act) provides that a police and crime commissioner must appoint a person to be the chief constable of the police force for the area.

The current Chief Constable, Mr. Anthony Bangham, notified the Commissioner of his decision to retire from his current position in September 2021. In response, a recruitment exercise was undertaken. At the conclusion of the recruitment exercise Ms Pippa Mills was identified as the preferred candidate for the post.

The proposed appointment of the Chief Constable was notified to the Police and Crime Panel. The Panel then reviewed the proposed appointment and made a report to the Commissioner recommending the appointment of the candidate.

To approve the appointment of Pippa Mills as Chief Constable for West Mercia Police.

SUPPORTING REPORT

- 1. Section 38 of the Police Reform and Social Responsibility Act 2011 (the Act) provides that a police and crime commissioner must appoint a person to be the chief constable of the police force for the area
- The current Chief Constable, Mr. Anthony Bangham, notified the Commissioner of his decision to retire from his current position in July 2016. In response, a recruitment exercise was undertaken. At the conclusion of the recruitment exercise Ms. Pippa Mills was identified as the preferred candidate for the post
- 3. In accordance with the provisions of the Act a report was provided to the Police and Crime Panel which included
 - the name of the person proposed for appointment;
 - the criteria used to assess the suitability of the candidate for the appointment,
 - why the candidate satisfied those criteria; and
 - the terms and conditions on which the candidate is to be appointed.
- The Panel recommended the appointment of Pippa Mills and was satisfied that the selection process was robust. The Panel's report to the Commissioner to this effect is at Appendix A. The terms and conditions of the appointment are set out at Appendix B
- 5. Pippa Mills will commence her duties as Chief Constable in September 2021
