EXECUTIVE SUMMARY

The national Forensic Collision Investigation Network (FCIN) collaboration was created in 2020. A Host Force (North Wales) operating model was created and underpinned by a collaboration agreement.

Work continues with UKAS to build an approach to accreditation that meets the first Host Force model of its type, whilst ensuring value for money in the cost of Police accreditation.

As the capability evolves and its requirements and opportunities better understood, an additional permanent Field Event Management post is required. This is an emerging requirement and is needed to co-ordinate, lead and manage critical accreditation activities, given there isn't capacity within the existing resource structure to undertake this work.

PROPOSAL

To approve funding for an additional permanent Field Event Management post within the FCIN to be funded out of part of the collaboration's projected 2021/22 underspend.

SUPPORTING REPORT

The national Forensic Collision Investigation Network (FCIN) collaboration was created in 2020. This was in response to the Forensic Science Regulators call for Forensic Collision Investigation activities to become ISO/IEC 17020 and ISO/IEC 17025 accredited, in line with other forensic disciplines. A Host Force (North Wales) operating model was created and underpinned by an APACE approved s22A collaboration agreement. The agreement included the creation of an FCIN Strategic Board.

Work continues with UKAS to build an approach to accreditation that meets the first Host Force model of its type, whilst ensuring value for money in the cost of Police accreditation.

As the capability evolves and its requirements and opportunities better understood, an additional permanent Field Event Management post is required. This is an emerging requirement and is needed to co-ordinate, lead and manage critical accreditation activities, given there isn't capacity within the existing resource structure to undertake this work
