TITLE: New licence for use of one parking space at the former Community Contact Centre in Evesham

EXECUTIVE SUMMARY

The Police and Crime Commissioner was approached by the charity The Vale of Evesham Community First Responders with a request to allow the parking of one Community Response Vehicle at the former Community Contact Centre in Evesham

The charity supports West Midlands Ambulance Service in providing urgent medical help to the local community Currently, they do not have a space to keep the vehicle when off-duty

It is considered that providing the parking space to the First Responders at this location will help response times and will cause no detrimental effect to policing

PROPOSAL

The recommendation is for the PCC to authorise the signing of a new licence with The Vale of Evesham Community First Responders, to permit parking of a single vehicle in an allocated bay at the former Community Contact Centre, Evesham

PART 1 – NON-CONFIDENTIAL/EXEMPT FACTS AND FIGURES

SUPPORTING REPORT

The Vale of Evesham Community First Responders are medically trained volunteers who are regulated and dispatched to life threatening 999 calls by West Midlands Ambulance Service. The charity is registered and works to increase awareness, availability and the use of life saving resources within the local community.

In June 2022, a response car was donated to the Community First Responders with the aim for it to respond to calls in Evesham, Pershore and Broadway It was decided that it is best to keep the vehicle in Evesham, however, the charity doesn't have premises with available parking.

The charity approached the OPCC through a local police officer with a request for the PCC to allow for the Community Response Vehicle to be parked at the former Community Contact Centre when off-duty. It is considered that providing the parking space to the First Responders at this location will help response times due to the proximity to Evesham Town Centre and the fact the location is almost equidistant from Pershore and Broadway.

The OPCC Estates Department recommends the signing of a licence with the charity in order to allow the use of one allocated parking space to the rear of the former Evesham Community Contact Centre (asset owned freehold by the PCC and currently used exclusively by West Mercia Police).

The proposed Heads of Terms are for the licence to be on a rolling term – it will renew automatically until cancelled by the either party with one week's notice. It is deemed that, as the charity

- Provides life-critical support to the local community;
- Works to support the ambulance service (a public sector partner of the PCC and West Mercia Police) and
- Is requesting only a parking space, no internal building premises

the annual licence fee should be nominal at £1

Under the proposed terms, the PCC is to remain responsible for all costs, compliance and maintenance of the premises. No additional estates costs are anticipated as a result of this arrangement. The occupiers will be responsible for the reinstatement of fixtures, fittings or surfaces which are damaged by their volunteers.

The proposal is for each party to cover for their respective legal charges in connection with the signing of the licence A quote has been obtained in connection with the projected legal costs for the PCC for the completion of the paperwork and it is estimated to be £500 (exclusive of VAT). The final amount will depend on the time incurred.
