EXECUTIVE SUMMARY

The Regional Organised Crime Unit (ROCU) is seeking permission to repurpose a flat screen television, seized as part of a policing operation, for policing purposes.

PROPOSAL

It is proposed that the Police and Crime Commissioner authorise the use of the television for operational policing purposes.

PART 1 – NON-CONFIDENTIAL/EXEMPT FACTS AND FIGURES

SUPPORTING REPORT

Following a policing operation in November 2021, police are in possession of a large flat screen television (identified as MJB/1326/191121, PMS CA/035697/21). Relevant individuals connected to the premises concerned have been convicted of an offence and, after serving their sentence, will be subject to deportation proceedings. There are no other individuals with a lawful claim to this property

The Regional Organised Crime Unit (ROCU) propose to repurpose this television to equip a new briefing/meeting room at one of their operational bases, to enable more effective briefing and training of officers and staff through use of programmes such as Powerpoint. By reallocating the equipment for use in this way, there will be a significant cost saving to police by removing the requirement to purchase a similar item new on the open market.

Section 2 of The Police Property Act (1897), as amended by the Police Property Act (1997) and the Police Reform and Social Responsibility Act (2011), provides that where property seized under the Act, other than money, has remained in the possession of the police for over a year, and where police would under the relevant legislation have the right to sell or dispose of the property, the Police and Crime Commissioner can assume ownership and authorise the use of such property for a policing purpose.
